Between Peter Hanson of South Cottonwood County of Salt Lake and Territory of Utah, party of the first part, and Hans Hanson of the Ward, County, & Territory aforesaid, the party of the second part, Witnesseth, That the said party of the first part, for and in consideration of the sum of (250.00) Two hundred & fifty Dollars, lawful money of the United States of America, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does, by these presents, grant, bargain, sell, convey and confirm unto the said party of the second part, and to his heirs and assigns forever.

All that certain Lot, piece, or parcel of Land, Situate, Lying, and being in South Cottonwood, County, & Territory, aforesaid, and Bounded and Described as follows To Wit Beginning at a point on East Side of the Utah Southern Rail Road & East line County Road, & at a point on a line bearing N. 88° 40' E.
