

TRUSTEE'S DEED



This Deed is made by J. SCOTT LUNDBERG, as successor Trustee under the hereinafter mentioned and described Trust Deed, in favor of WESTERN SAVINGS AND LOAN COMPANY, 41 East 100 South, Salt Lake City, Utah 84111, as Grantee.

WHEREAS, on April 15, 1985, BERTAGNOLE INVESTMENT COMPANY LIMITED PARTNERSHIP, as Trustor, executed and delivered to WESTERN SAVINGS AND LOAN COMPANY, as Trustee and Beneficiary, a certain Trust Deed to secure the performance by said Trustors of their obligations under a Promissory Note executed and delivered for a valid consideration to WESTERN SAVINGS AND LOAN COMPANY on or about April 15, 1985. Said Trust Deed was recorded in the office of the Recorder of Salt Lake County, State of Utah, on April 17, 1985, as Entry No. 4074969 in Book 5646 at Page 1785, and covered the property hereinafter described; and

WHEREAS, breach and default was made under the terms of said Trust Deed in the particulars set forth in the Notice of Default hereinafter referred to; and

WHEREAS, J. SCOTT LUNDBURG was duly appointed by the Beneficiary as successor Trustee by a Substitution of Trustee dated March 19, 1986, and recorded in the Office of the County Recorder of Salt Lake County, State of Utah, on April 9, 1986, as Entry No. 4227364 in Book 5754 at Page 382; and

WHEREAS, J. SCOTT LUNDBERG, successor Trustee under said Trust Deed, executed and thereafter filed for record in the Office of the County Recorder of Salt Lake County, a written Notice of Default containing an election to sell the trust property, which Notice of Default was recorded on April 9, 1986, as Entry No. 4227365 in Book 5754 at Page 386; and

WHEREAS, the successor Trustee in consequence of said declaration of default, election and demand for sale, and in accordance with said Trust Deed, did execute his Notice of Trustee's Sale stating that he, as such Trustee, by the virtue of the authority in him vested, would sell at public auction to the highest bidder for cash; in lawful money of the United States, the property therein and hereafter described, and fixing the time and place of said sale as October 30, 1986, at 10:15 a.m. of said day, Courts Zuilding, Salt Lake City, and did cause copies of said notice to be posted for not less than 20 days before the date of sale therein fixed, in three public places in the county wherein said property is located, and also in a conspicuous place on the property to be sold; and said successor Trustee did cause a copy of said notice to be published once a week for three consecutive weeks before the date of sale therein fixed in the Salt Lake Times, a newspaper having a general circulation in the county in which the property to be sold is situated, the first date of such publication being October 3, 1986, and the last date being October 17, 1986; and

WHEREAS, all applicable statutory provisions of the State of Utah and all of the provisions of said Trust Deed have been complied with as to the acts to be performed and the notices to be given; and

WHEREAS, said successor Trustee did at the time and place of sale fixed as aforesaid did postpone said sale until Friday, October 31, 1986 at 3:00 p.m. and did then and there sell, at public auction, to Grantee above named, being the highest bidder therefor, the property described for the sum of \$2,216,640.00 paid in cash, lawful meney of the United States of America.

NOW, THEREFORE, successor Trustee, in consideration of the premises recited and of the sum above mentioned, bid and paid by Grantee, the receipt whereof is hereby acknowledged, and by virtue of the authority in him by said Trust Deed, does by these presents grant and convey unto Grantee above named, but without any covenant or warranty, express or implied, all of that certain property situated in Salt Lake County, State of Utah, described as follows:
